



# MEMBERS' RULES AND REGULATIONS FOR THE FRIENDS OF THE IMPERIAL MUSEUM

The Members' Rules and Regulations for the Friends of the Imperial Museum (the "Members' Rules") of Imperial Museum Limited (the "Museum") are applicable to all members of the Friends of the Imperial Museum (the "Members"). All the Members have to comply with the Members' Rules.

#### MEMBERSHIP AND CLASSES

- Membership is divided into different classes, namely Individual Members (including Sustainable Members (Individual)), Corporate Members (including Sustainable Members (Corporate)), Sponsors, Patrons, Honorable Members and Associates Members. The Museum may amend and update the structure of the membership classes as necessary.
- 2. The Members may enjoy all the benefits granted to their respective membership classes during the validity of their memberships. The Museum may alter the benefits of each membership class from time to time as necessary.
- 3. All the Members and their authorized representatives (for Corporate Members), except for Associate Members, must be over 18 years of age.
- 4. Each Corporate Member may nominate 2 individuals as its authorized representatives to enjoy the membership benefits. No changing of representatives is allowed without notifying the Museum. To effect any change of representatives, Corporate Members have to inform the Museum with 30 days' prior written notice, receiving the Museum's returned confirmation.
- 5. Different membership classes have their own applicable valid periods and payable fees. A membership shall only be valid when the applicable membership fee is paid in full.
- 6. All applications for membership renewal are subject to the approval of the Museum. The Museum has the absolute discretion to approve or reject any of such renewal applications without giving any reason therefor.
- 7. The Museum has the absolute discretion to determine the valid period of a membership and to specify how it will be renewed. Without prejudice to the generality of the foregoing, the Members shall, upon the Museum's request, provide the necessary proofs or supporting documents to the Museum for substantiating their eligibility for the membership renewals.
- 8. The Members have neither the voting rights as to the constitution, operation or management of the Museum nor any rights in or any claim over any assets of the Museum.
- 9. The respective members' benefits of each membership class are personal to the Members or their authorized representatives (if applicable). All memberships of the Museum are non-transferable.





#### **MEMBERSHIP APPLICATION**

- 1. Each membership application shall be proposed or nominated by an existing member of the Friends of the Imperial Museum. Membership application evaluation and approval normally takes 10 weeks.
- 2. The Members shall ensure each nominee they nominate and propose is a person of integrity and is suitable to become a member of the Friends of the Imperial Museum for contributing to the art and culture development.
- 3. Applicants shall ensure all the information provided is true and correct. False and misleading statements may lead to rejection of applications. A member shall be expelled if the previously approved and admitted membership is found carrying false and misleading statements.
- 4. All membership applications are subject to the approval of the Museum. The Museum has the absolute discretion to approve or reject any application without giving any reason therefor.
- 5. By signing and submitting the form for membership application, the applicant acknowledges and agrees to be bound by the Members' Rules (including any clauses being in force from time to time) when the membership is approved and becomes effective. For online membership application, the applicant acknowledges and agrees to be bound by the Members' Rules when the online form is submitted.
- 6. Applicants may need to provide supporting documents, as required, to the Museum in processing their membership applications.
- 7. Annual membership fee applies to successful applications only. The prepaid membership fee, if any, shall be refunded if the membership application is rejected.

#### **MEMBERS' BENEFITS AND RESPONSIBILITIES**

- 1. A member shall be admitted when the membership approval is given and the applicable membership fee is paid in full. The Members shall be eligible to enjoy the services and benefits provided by the Museum and to visit the Museum by prior appointment, subject to specific conditions, rules and venue regulations imposed by the Museum in relation to such services and visits. The Museum has the absolute discretion with respect to the arrangements and processing of any of the Members' requests.
- 2. The Museum shall have the absolute right and discretion to provide services to different Members under appropriate circumstances and conditions. The Museum may further suspend or terminate the provision of any service to the Members at any time as necessary without giving prior notice or reason.
- 3. The Members shall arrive on time for museum visits or activities, and shall abide by the venue regulations. The Museum reserves all rights to reject admission or participation of any member if the Museum's instructions are not followed.

- 4. The Members shall pay annual membership fees before due and update their personal data and contact information to the Museum in a timely manner. The Members shall respect the rights of other members when enjoying members' services and benefits.
- 5. No member shall use the facilities and services of the Museum, or any information or documents provided or procured by the Museum, for any commercial, immoral or illegal purposes.
- 6. The Museum shall not be liable to the Members or any other person for any losses incurred, whether directly or indirectly, in using the facilities or in subscribing to the services of the Museum or in enjoying the Members' benefits in all circumstances. The Museum shall assume no responsibility of damages, fees or indemnity arise thereof in any form or of any amount.
- 7. The Museum reserves all rights to charge individual members for rendering additional services and/or delivering specific information or documents by the Museum according to their special requests. The charge shall be a reimbursement of the additional costs and expenses incurred by the Museum in providing such services, in which case the Museum shall advise the individual members about the amount to be charged before the service or information is delivered.

#### AMENDMENT OF RULES AND REGULATIONS

The Museum shall have the absolute right and discretion to amend the Members' Rules from time to time without prior notice. The latest and updated version of the Members' Rules is available on the website of the Museum (<a href="www.imperial-museum.org">www.imperial-museum.org</a>). All clauses of the Members' Rules will become effective immediately when they are published on the website.

#### **TERMINATION OF MEMBERSHIP AND EXPULSION OF MEMBERS**

- 1. A membership shall be suspended for overdue and unsettled membership fee. If the overdue membership fee remains outstanding for two months, the Museum may terminate the membership without further notice.
- 2. The Museum may expel a member for violating any rule under the Members' Rules, for depriving other members of their respective rights, and for material misconducts or improper acts causing damage to the interest or reputation of the Museum or other members. This rule also applies to the authorized representatives of Corporate Members. A member who has been expelled from the Museum shall receive a written notice from the Museum for such expulsion, and all unused membership fee shall not be refunded. In all circumstances, the decision of the Museum shall be valid and conclusive.
- 3. A member who has been expelled from the Museum shall cease to have any rights and benefits attached to the membership with immediate effect. The expelled member shall no longer be eligible to enjoy the facilities and services of the Museum.





- 4. The expelled member is fully liable for his/her misconduct or improper act, and shall assume full responsibility to indemnify the Museum or other members for any losses, whether direct or indirect, arising out of such misconduct or improper act.
- 5. Members may, for whatever reason in seeing themselves no longer suitable to be a member, terminate their memberships by giving 30 days' prior written notice to the Museum to that effect. There shall be no refund of the unused membership fees.

### TERMINATION OF OPERATION OF THE FRIENDS OF THE IMPERIAL MUSEUM BY THE MUSEUM

In unforeseeable circumstances which are beyond the control of the Museum, the Museum shall have the absolute discretion to terminate the operation of the Friends of the Imperial Museum without giving any reasons to the Members. Upon the termination of the operation of the Friends of the Imperial Museum, all members' services, rights and benefits shall discontinue, and no claim or demand of whatsoever nature and howsoever arising shall be made by the Members against the directors, shareholders or management of the Museum in connection with such termination.

#### **PERSONAL DATA**

- Each applicant for membership shall submit all true and correct personal data and related information requested in the application form for the Museum's consideration and evaluation. Failure to do so may delay application processing, resulting in membership rejection. On successful application, further personal data and information may be collected during the membership period.
- 2. Personal data and information relating to an applicant or the Members may be used by the Museum to facilitate or in connection with any or all of the following purposes:
  - (a) processing of membership application;
  - (b) assessment and/or verification of information supplied to the Museum;
  - (c) promoting, improving and/or furthering the provision of facilities, services and/or products of the Museum;
  - (d) facilitating communications between the Members and the Museum and soliciting feedback from the Members on their needs and expectations of the Museum's facilities, services and products;
  - (e) meeting any statutory requirements to make disclosure under any applicable law; and
  - (f) any other purposes which an applicant or the Members may from time to time agree.





3. Each member has the right to request access to and correction of any of his/her personal data established to be inaccurate. The Museum reserves all rights to charge a reasonable fee for the processing of any data access request. Any data access or correction request may be made with 14 days' prior written notice to the Museum at its office situated at 6/F Eltee Building, 3 Ning Foo Street, Chai Wan, Hong Kong (Telephone No. 2810 9595 and Fax No. 2810 9599). The Museum shall make arrangement for any such requests unless it may or is required to refuse to do so under the applicable laws and regulations.

#### APPLICABLE LAW

The Members' Rules shall be governed by and construed in accordance with the laws of the Hong Kong Special Administrative Region.

## **GOVERNING VERSION**

Wherever there is any discrepancy between the English and Chinese versions of the Members' Rules, the English version shall prevail.
